All dogs must be held on leash, except during trial. Dogs must be kept a suitable distance away from the trial area. Handlers should bring water and shade and pick up after their dogs.

This Show will be open from 6 AM to 7 PM. CONSULT JUDGING PROGRAM for time of judging. JUDGES ARE NOT REQUIRED TO WAIT for dogs. They will adhere as closely as possible to the judging schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. DOGS NOT REQUIRED for further judging will be excused.

ENTRY FEE shall not be refunded in the event that the dog is absent, excused by the judge or veterinarian, or barred from competition by action of the Show Committee.

Errors on entry forms: Owners are responsible for errors in making out entry forms (whoever may make such errors) and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. Please type or print clearly and carefully the information on entry forms to eliminate errors.

LUNCH— Exhibitors should bring a bag lunch and plenty of water for themselves and their dogs.

Entries will not be accepted without fees. Returned checks do not constitute a valid entry. The Herding Secretary will add a collection fee to the amount of each returned check. Canadian exhibitors must submit entries with an international money order guaranteed in U.S. funds.

If sending entries overnight, make sure to **sign the waiver** that allows them to leave packages without a signature, Requiring a signature will only delay receipt of your entries.

A separate entry form must be submitted for each entry. Entries not on official AKC entry forms or photocopies with out the agreement and rules are unacceptable. Telephone, telegraph, fax and unsigned entries cannot be accepted. Changes additions or corrections to entry forms must be received in writing prior to the close of entries. No refund for duplicate entries or any other cause beyond the control of the club after the closing date.

The club may decline entries for cause and may refuse to receive or remove any dog on account of disease, viciousness, or other cause and no one shall have any claim or recourse against the club or any official thereof.

PLEASE NOTE: Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable disease and have appropriate vaccinations.

Agreement

I (We) acknowledge that the "Rules Applying to Dog Shows/Registration and Discipline," and the "Rules for Herding Test or Trials", have been made available to me (us), and that I am (we are) familiar with their contents. I (we) agree to hold the AKC and any AKC approved judge harmless from any legal claim resulting from said AKC judge's action under the "AKC Rules, Regulations and Guidelines."

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold the AKC, the event giving club, their members, directors, governors, officers, agents superintendents or event secretary and the

owner or lesser of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. DIRECTIONS

From East – Interstate 190 South to Exit 3 (West Mountain Street) Right at end of exit ramp on West Mountain Street. Left at light onto Shrewsbury Street to end in Holden. Turn right onto Route 122A to Route 31. Turn left onto Route 31 in Paxton. The Farm is on Route 31, three miles from the lights in Paxton. It is at the top of the hill just after the Spencer town line. Red barn on left, white house on right.

From Interstate 290 in Worcester – Take Interstate 190 North - Exit 2. At light at end of off ramp, cross over (do not turn at light). Continue to West Mountain Street. Turn left and continue as above.

From Mass Pike (90) in Sturbridge – Take Sturbridge Exit Go East on Route 20. Left on Route 49 to Spencer. At end, turn right on Route 9. Then left on Route 31. After passing the Black & White Restaurant, the Farm will be .8 miles on top of hill. Red barn on right, white house on left.
