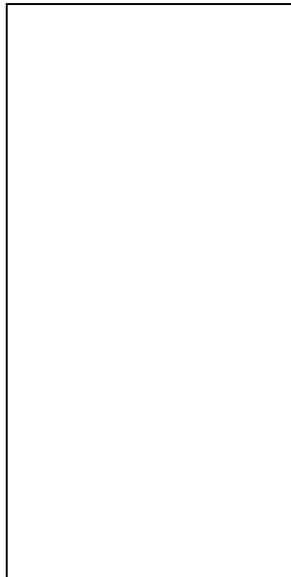

**Entries will not be accepted without fees.** Returned checks do not constitute a valid entry. The Herding Secretary will add a collection fee to the amount of each returned check. Canadian exhibitors must submit entries with an international money order guaranteed in U.S. funds.

**Entries not on official AKC entry forms or photocopies without the agreement** and rules are unacceptable. Telephone, telegraph, fax, and unsigned entries cannot be accepted. Changes, additions, or corrections to entry forms must be received in writing prior to the close of entries. No refund for duplicate entries or any other cause beyond the control of the club after the closing date.

**The club may decline entries** for cause and may refuse to receive or remove any dog on account of disease, viciousness, or other cause, and no one shall have any claim or recourse against the club or any official thereof.

**Proof of current rabies vaccination** must be furnished upon request.

**All dogs must be held on leash**, except during tests or trials. Dogs must be kept a suitable distance away from the test/trial area. Handlers should bring water and provide shade for their dogs. Handlers are required to pick up after their dogs.
